

IMAGING COMMITTEE

TERMS OF REFERENCE FEBRUARY 2018

REPORTING RELATIONSHIP

- 1. The committee is a standing committee of the Canadian Organization of Medical Physicists (COMP).
- 2. The Chair of the committee reports to the COMP Board.
- 3. The Chair will present a written report to the COMP Board prior to each in-person meeting of the Board.

PURPOSE

The Imaging Committee will:

- 1. act as a united voice for medical physicists who specialize in medical imaging in Canada; and,
- 2. serve as COMP's authority on issues related to imaging physics.

RESPONSIBILITIES AND DUTIES

- 1. Provide the COMP Board with imaging physics expertise.
- 2. Advise the COMP Board on how to respond, or respond on behalf of COMP, to imaging physics requests from industry, provincial health ministries, Health Canada, and other organizations.
- 3. Liaise with Science and Education committees for imaging-related programs.
- 4. Promote the development of guidelines for medical imaging.
- 5. Support the development and revisions of safety codes and guidelines as related to medical imaging and to promote provincial and territorial adoption of these documents.
- 6. The committee may appoint sub-committees or ad-hoc task forces as required.

MEMBERSHIP

The Committee should be composed of:

- 1. a Chair who is appointed by the COMP Board for a term of three years;
- 2. the COMP Board president ex officio;
- 3. Executive Director of COMP ex officio;
- 4. no less than 5 and no more than 9 additional committee members who are:
 - a. COMP members in good standing;
 - b. when possible and preferred, representatives of provincial medical physics professional associations;
 - c. an appropriate mix, at the discretion of the Chair, of x-ray, nuclear medicine, magnetic resonance and ultrasound physicists located over a wide geographical distribution;

5. guests who, at the call of the Chair, are co-opted to attend specific meetings to deal with specific issues or projects.

Committee members will be invited to serve a term of 3 years on the committee and may serve a maximum of two consecutive terms. A Committee member who has completed two terms, may rejoin the committee after a one-year period. Note: In special circumstances, the Committee Chair may deem that the committee will be best served by the continued participation of a member who has completed two terms. In these circumstances, the Committee Chair may choose to invite the member to continue on the committee.

MEETINGS

- 1. The committee should meet a minimum of two times a year.
- 2. A quorum consists of a majority of members, which includes the committee chair.
- 3. Summary minutes of meetings will be taken and all decisions shall be recorded.
- 4. The committee should function as far as possible by consensus; otherwise, a majority decision will be respected. The chair shall have the deciding vote in the case of a tie. Recommendations to the COMP Board may also include a minority opinion.

BUDGET

The Chair will submit an annual budget to the treasurer.
